Your Excellency,

The Economic and Commercial Office of the Embassy of the People's Republic of China in the Hashemite Kingdom of Jordan extends its respectful greetings to Your Excellency and is pleased to announce the 2025 scholarship programs sponsored by the Ministry of Commerce (MOFCOM) of the People's Republic of China.

1. Information of the Programs

The programs are categorized into two types: **University Programs** and **CSC Programs**. Applicants are required to choose only one type.

In 2025, 30 University Programs are available for Jordanian applicants, and a comprehensive list is provided in Attachment 1. Enrollment Guides and detailed descriptions of individual programs can be accessed via the following link:

Details regarding CSC Programs will be announced at a later date.

2. General Eligibility Criteria:

Applicants must

- 1) Hold positions as government officials, or be engaged as research or technical staff within enterprises, educational or research institutions, and must be born after September 1, 1980;
- 2) Possess valid Jordanian ORDINARY passports with an expiry date no later than March 1, 2025;
- 3) Have a minimum of two years of relevant work experience;
- 4) Hold a bachelor's degree to apply for master's programs and a master's degree to apply

for PhD programs;

5) Demonstrate proficiency in the working language of the proposed program;

6) Be in good physical and mental health, supported by a medical examination report issued by licensed physicians or medical institutions after April 30, 2025. Female candidates should not be pregnant;

7) Not be currently studying in China or admitted to other scholarship programs provided by the Chinese government.

Specific conditions required by individual programs can be found in their respective Enrollment Guides. Participants are advised against bringing along family or friends during their study tenure in China.

3. Scholarship Coverage

The scholarship covers tuition fees, on-campus accommodation, monthly stipends, one-time resettlement fees, medical insurance, and international round-trip airfare. Further details are outlined in the Enrollment Guides.

4. Enrollment Procedure

1) MOPIC nominates candidates;

2) The Economic and Commercial Office conducts interviews with candidates;

3) The Economic and Commercial Office issues Letter of Recommendations to eligible candidates;

4) Candidates complete the online application on the websites of respective universities before June 6, 2025, following the instructions provided in the Enrollment Guides;

5) Universities conduct selections;

6) MOFCOM announces the results.

It is imperative that candidates carefully review and adhere strictly to the guidelines provided in the Enrollment Guides.

The Economic and Commercial Office respectfully requests MOPIC to nominate candidates, meticulously review their application materials as per the Enrollment Guides, and furnish the following documents (All documents should be in English or Chinese. Otherwise, a notarized copy in English or Chinese is mandatory) to the Economic and Commercial Office by May 20, 2025. Hard copies should be submitted to the embassy at No. 9 Jakarta Street, Amman, while electronic copies are to be sent to jojsc@yahoo.com.

1. Recommendation List, one hard copy with MOPIC official stamp and one electronic copy (Attachment 2);


2. Documents of individual candidates, both originals (except passport) and electronic copies:

- 1) Identification page of ORDINARY passport (hard copy and electronic copy);
- 2) Foreigner Physical Examination Form (Attachment 3);
- 3) Highest diploma;
- 4) Academic transcripts;
- 5) English proficiency certificate;
- 6) Non-criminal Record Report.

The Economic and Commercial Office avails itself of this opportunity to renew to the MOPIC the assurances of its highest consideration.
