# Introduction

---

The Economic Modernisation Vision is an essential pillar within the course of comprehensive reform called for by His Majesty King Abdullah II Ibn Al-Hussein with the goal of unleashing national potential in various sectors. An effort to forge inclusive and sustainable growth that ensures creating job opportunities for Jordanians and ensuring a better quality of life for citizens. The Speech from the Throne at the Opening of the Second Ordinary Session of the 19th Parliament contained ten clear Royal directives for the government to move forward with the reform process and emphasized the importance of the Economic Vision in attracting investment, supporting economic growth, and providing job opportunities for young Jordanians over the next decade.

The Vision included key principles for drawing a clear roadmap for the future of Jordan, in which the private sector would play a pivotal role in the economic activity, based on two strategic pillars: accelerated economic growth and improved quality of life for all citizens, while sustainability is a cornerstone of this Vision in an effort to achieve the national priority goals, with the overarching goal of generating one million new jobs for Jordanians in the labor market.

The Executive Program for the Economic Modernisation Vision (2023-2025) reflects the government's commitment to delivering the Modernisation Vision as a key pillar in the comprehensive modernisation process led by His Majesty the King in its three political, economic and administrative spheres, including initiatives, projects, legislations and priority procedures in the various development sectors, which all relevant ministries and institutions will put into practice within the timelines contained therein. The Executive Program for the Economic Modernisation Vision (2023-2025) serves as a starting point for subsequent Executive Programs, thereby paving the way for achieving targets related to growth, job creation, investment and partnership with the private sector.

The program comes in light of the exceptional economic and financial challenges experienced by Jordan due to global crises, external shocks and their aftermath on the economic sectors. Its development has also coincided with the completion of the Fifth



Review of the Economic Reform Program developed by the Government of Jordan and supported by the International Monetary Fund (IMF). A review that commended Jordan's reform approach and the prudence of its fiscal and monetary policies, while maintaining future growth projections of economic performance within the present levels under these exceptional circumstances.

The executive program, which is complemented by the Public Sector Modernization Roadmap, features (135) initiatives as part of the vision's eight drivers (High Value Industries, Future Services, Destination Jordan, Smart Jordan, Sustainable Resources, Invest Jordan, Green Jordan, and Vibrant Jordan), adopted according to the readiness and availability of funding, taking into account the alignment with the economic reforms matrix, sustainable development goals, and contribution to providing added value for growth and employment, and enhancing partnership with the private sector, as the total cost of the program is JD 2.115 billion until the end of 2025. The program also included the review, amendment and approval of legislative packages and action plans to improve Jordan's ranking in international indicators and reports.

The Executive Program is featured by its inclusion of initiatives associated with women's economic empowerment, including legislative reviews and measures to improve Jordan's ranking in the Global Gender Gap Index, as well as the continued implementation of the action plan related to improving Jordan's ranking in the Women, Business, and the Law Report, and development of a national index to monitor and track women's economic participation.

In developing the Priorities Program, the government has pursued the same participatory approach, which was the title for the Vision's development process. Whereas sectoral task forces were formed, whose membership includes the public sector, along with representatives of the private sector and experts from different sectors and were key to the development process by reviewing the Vision's document and its proposed initiatives, aligning them with the sectoral strategic plans and elaborating the final output of the Vision's Executive Program in a form that reflects the goals and aspirations of the Vision.

Moreover, the Executive Program is a living and flexible document that is subject to annual revision and assessment in line with the government's economic developments and priorities. As such, it includes a specific timeframe for implementation, clear indicators to measure performance, and an online system to monitor progress.

## Summary of the Economic Situation

The Jordanian economy achieved positive results during the period (2009-2020), supported by growth in national exports, an increase in foreign investments, and a rise in the pace of remittances from Jordanians working abroad, with an average growth rate of 6.5% during that period.

Due to the repercussions of the global financial and economic crisis in 2009, and the ramifications of the security instability in the region in 2011, followed by the influx of around 1.3 million Syrian refugees into the kingdom, and the resulting pressures on public finances and essential government services such as health, education, transportation, water, sanitation, among others, in addition to the repercussions of the COVID-19 pandemic, the economic growth rate slowed down during the period (2010-2022), averaging not more than 2.2%.

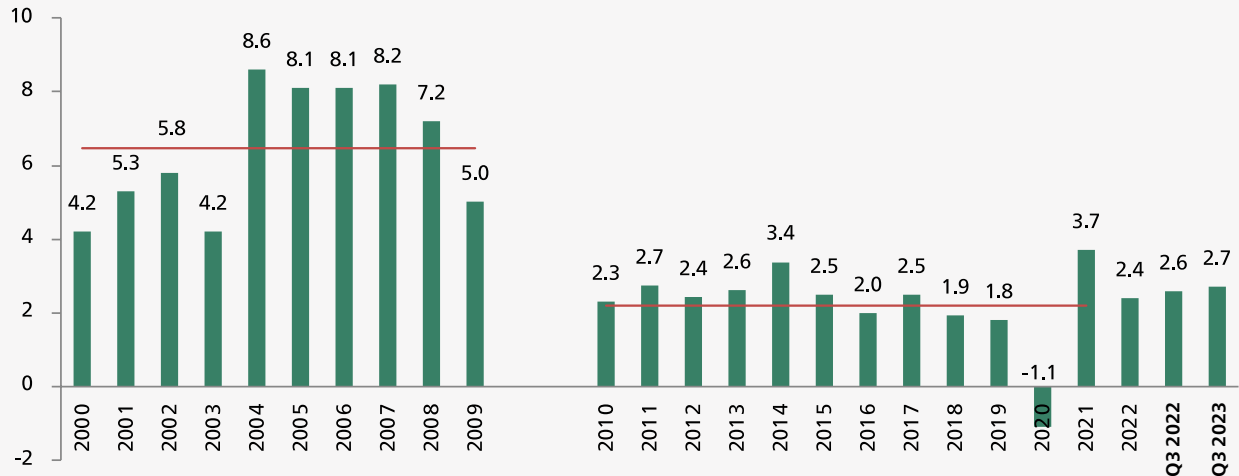
Despite the economic contraction caused by the pandemic, which reached 1.1% in 2020, the national economy has shown a clear trend towards recovery from its effects during the year 2021, driven by government measures taken in the healthcare sector, monetary and fiscal measures taken to mitigate the pandemic's effects, including lifting lockdown measures and allowing economic sectors to operate, leading to positive growth of 3.7% during the year 2021. The positive growth rate continued during the year 2022, reaching 2.4%, driven by the revival of tourism, full economic reopening, and improvement in exports. During the first three quarters of 2023, the economic growth rate reached 2.7% compared to 2.6% during the first three quarters of 2022.

### Real GDP Growth Rate Trend

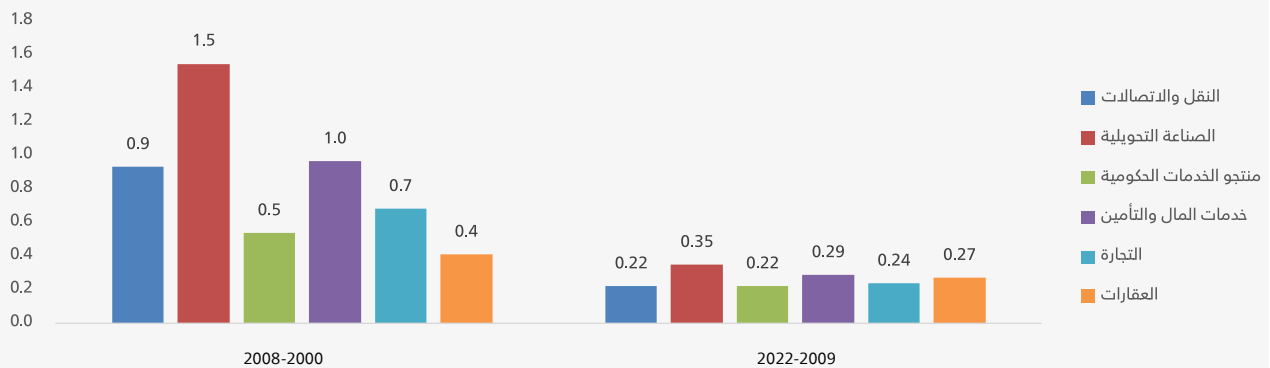
The shocks that the national economy underwent during the past decade have led to a general change in the structure and composition of the economy. On the supply side, the real estate sector has risen to the third position in terms of its contribution to the real economic growth rate (0.27% or equivalent to 11.3% of the real growth rate, which is 2.4%) during the period 2009-2022, surpassing important sectors such as transportation and trade. On the

demand side, private consumption expenditure has expanded due to the influx of around 1.3 million Syrian refugees into the kingdom, at the expense of government consumption expenditure and gross capital formation, while the relative importance of net exports in gross domestic product has improved. Consequently, there is an urgent need for further diversification of economic activity and a shift towards an economy that relies more on productive sectors for its growth and is capable of producing exportable goods and services.

Average Real GDP Growth Rate 2.4%

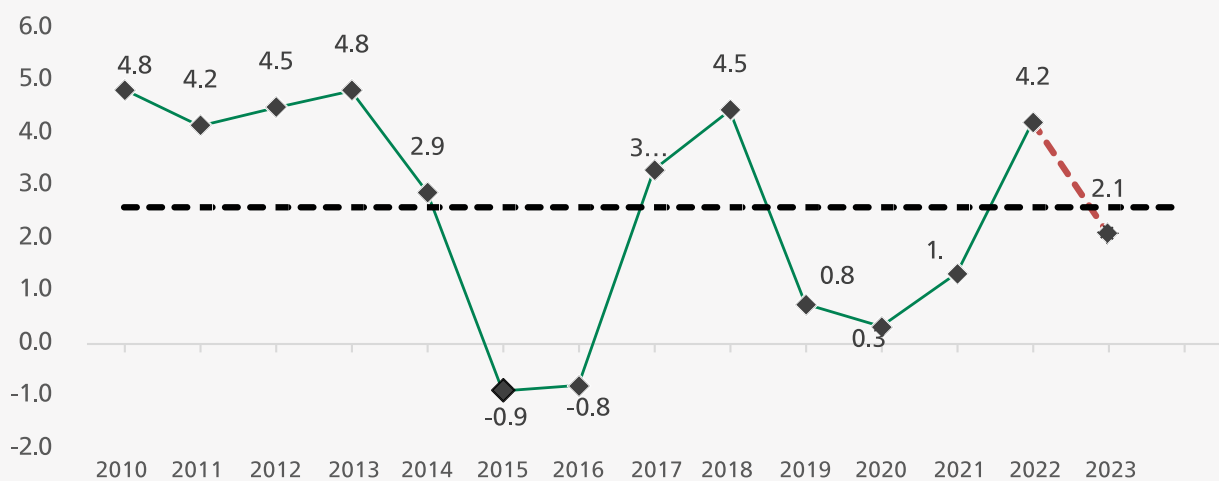


## Inflation Rate

The inflation rate recorded moderate levels during the period (2010-2023), averaging 2.6%. This is despite the liberalization of oil derivatives prices in 2012 and the upward trend of oil prices during that period and the subsequent period. Due to the decrease in domestic demand and global prices as a result of the lockdowns caused by the COVID-19 pandemic, the inflation rate decreased to 0.3% during the year 2020. It then rose to 1.4% in 2021

due to the return of growth rates to pre-pandemic levels. However, during the year 2022, due to the expansion of global inflationary pressures resulting from the rise in food and energy prices, the annual inflation rate increased to 4.23%. Fiscal and monetary policies and preemptive measures by the government to contain inflationary pressures contributed to this, with the inflation rate reaching 2.1% by the end of 2023, compared to 4.2% in 2022.

Average Inflation Rate (2010-2023) 2.6%

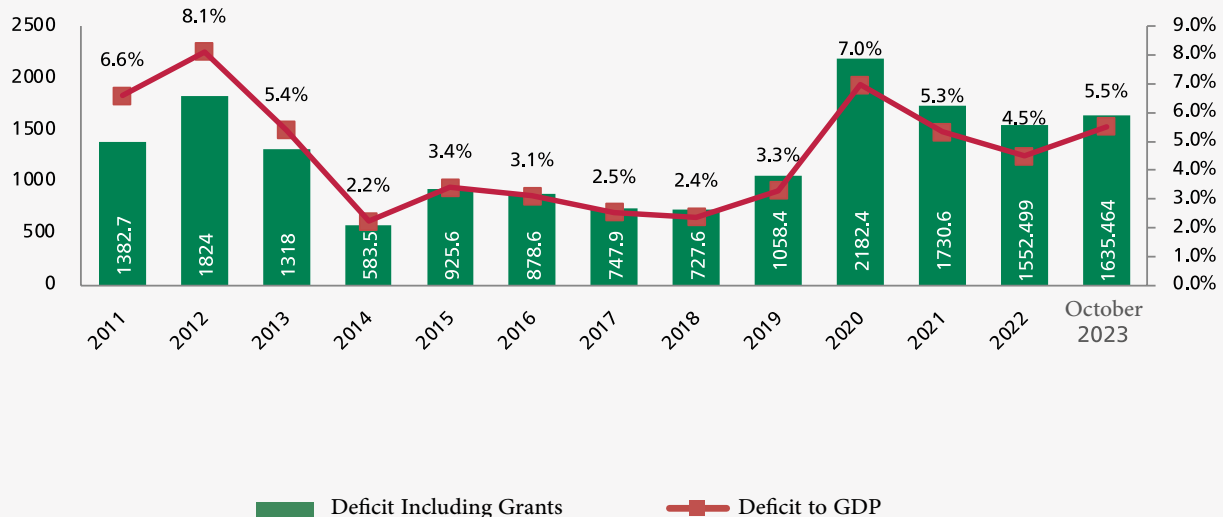


## Public Finance Sector

- General Budget:** General Budget: The general budget has been suffering from a chronic deficit that reached record levels of around 8.1% of the Gross Domestic Product (GDP) (after grants) in the year 2012. This was primarily due to a decline in the overall revenue growth rate, with relatively stable expenditure levels. Various financial reforms, especially in the tax system, had a significant impact on stabilizing public finance indicators, leading to a decrease in the budget deficit to 2.4% of the GDP in 2018. However, the financial repercussions of the

COVID-19 pandemic raised the budget deficit to 7% of the GDP in the year 2020. Reflecting the economic recovery status, the government managed to achieve the targeted estimates for local revenues in the General Budget Law during the year 2021. This resulted in a decrease in the actual budget deficit to 5.3% of the GDP. The deficit continued to decrease in 2022, reaching 4.5% of the GDP. Meanwhile, the fiscal deficit after grants amounted to 5.5% during the first ten months of 2023 compared to the same period of the previous year.

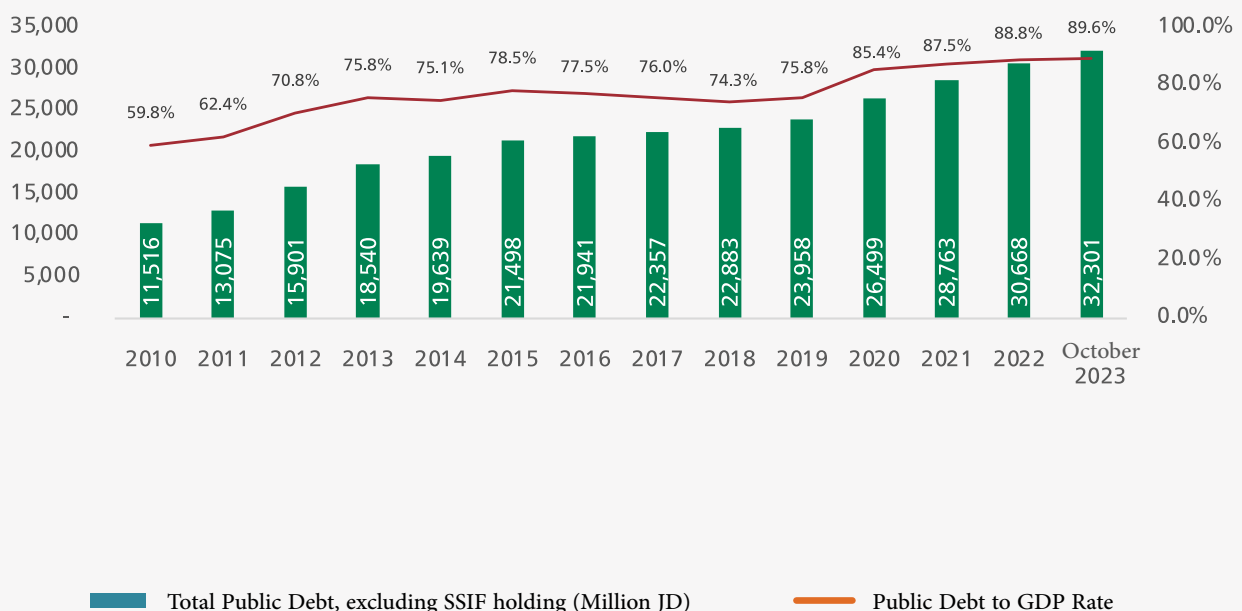
### Deficit as percentage of GDP



- Public Debt:** The public debt averaged 74.8% of the Gross Domestic Product (GDP) during the period (2011-2020) as a result of the continuous deficit in the general budget. Its ratio reached 85.4% in 2020, the highest during this decade, due to the repercussions of the COVID-19 pandemic on the budget and the burdens of financing the deficit of the Water Authority and the installments of the guaranteed loans for the Jordan Electric Power Company. The public debt continued to rise in 2021 to 87.5% after excluding what the Social Security Investment Fund (SSIF) holds. It reached 88.8% of the GDP during 2022.

Regarding the year 2023, available data for the first ten months of the year show an increase in public debt to 89.6% of the GDP after excluding what the Social Security Investment Fund (SSIF) holds, amid intense pressure on the general budget. Despite the challenges related to the budget deficit and levels of public debt, the government managed to meet the requirements of the Economic Reform Program 2020-2024 while maintaining the Kingdom's credit rating issued by international credit rating agencies, despite the economic conditions experienced by all countries worldwide.

## Monetary Sector

During the period from 2010 to 2022, the monetary sector achieved positive results, characterized by maintaining comfortable levels of foreign reserves sufficient to cover imports of goods and services for an average of 7.2 months, which exceeds twice the international standard. The total foreign reserve balance reached approximately 17.3 billion dollars at the end of 2022, compared to 13.0 billion dollars at the end of 2010. Bank deposits also increased by an average of 5.8% annually to reach about 42.1 billion dinars by the end of 2022, compared to 22.5 billion dinars at the end of 2010.

Credit facilities for all economic sectors also increased by an average of 7.2% annually to reach 32.6 billion dinars at the end of 2022, compared to 14.5 billion dinars at the end of 2010. Local liquidity recorded an average annual growth rate of 5.9% to reach about 41.7 billion dinars at the end of 2022, compared to about 22.3 billion dinars at the end of 2010.

Despite ongoing global challenges and uncertainty due to geopolitical situations and the continuation of the global inflationary wave during 2023, the total foreign reserve balance reached 17.5 billion dollars at the end of October, sufficient to cover the Kingdom's imports of goods and services for about 7.7 months. The dollarization rate decreased to 18.0% at the end of October 2023, compared to 18.7% at the end of 2022, and 19.0% at the end of 2021. Moreover, the total deposit balance increased

by 1.4 billion dinars (3.3%) annually to reach about 43.3 billion dinars at the end of October 2023, with most of it being in dinar deposits. Credit facilities also increased by 3.1% to reach approximately 33.3 billion dinars at the end of October 2023 compared to the same period of the previous year.

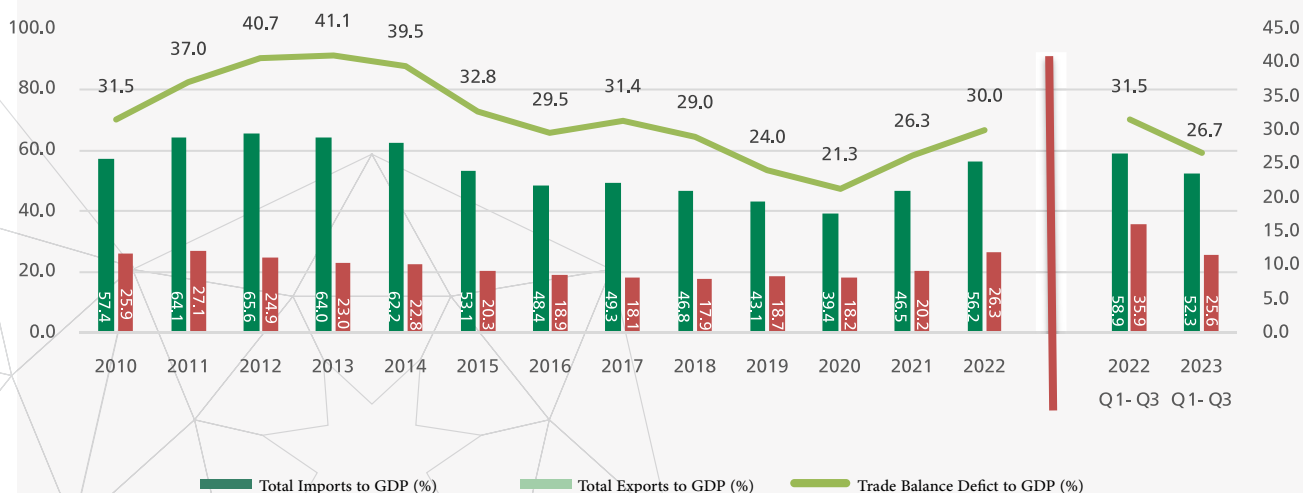
## Foreign Trade

The Jordanian economy is generally influenced by changes in the global economy and particularly by the economies of its trading partners, owing to the relatively small size of the Jordanian economy and its openness to the external world. The Jordanian economy faces numerous challenges, including scarcity of primary resources and the regional and global political conditions and their impact on the movement and prices of goods.

- **Trade in Goods:** Trade in goods constituted approximately 80% of the Kingdom's Gross Domestic Product (GDP) on average over the past two decades. Imports have comprised the larger portion of this trade due to the weakness of the industrial base and heavy reliance on the external world to provide various types of goods and production inputs. Consequently, the trade

balance has suffered from a chronic deficit, averaging 33% of the GDP annually over the past two decades. However, this deficit decreased to 21.3% during the year 2020 due to a larger decrease in the value of imports compared to exports, resulting from the conditions of the COVID-19 pandemic and the decline in global trade volume. The deficit increased to 26.3% during 2021 as recovery began and activity resumed. Subsequently, the deficit returned to its previous levels, reaching around 30% during 2022, due to rising commodity prices and increased demand.

During the first three quarters of the year 2023, and as a result of the global decline in commodity prices, the total exports of the Kingdom decreased by 2.4% compared to the same period in 2022, reaching 6764.0 million dinars. This decrease was due to a 2.0% reduction in national exports, which amounted to 6272.0 million dinars, and a 7.3% decrease in re-exported goods, amounting to 492.0 million dinars.

Imports also decreased during the first three quarters of 2023 by 7.0% compared to the same period in 2022, amounting to 13841.6 million dinars.

Consequently, the deficit in the trade balance (which represents the difference between the value of imports and the total value of exports) decreased during the first three quarters of 2023

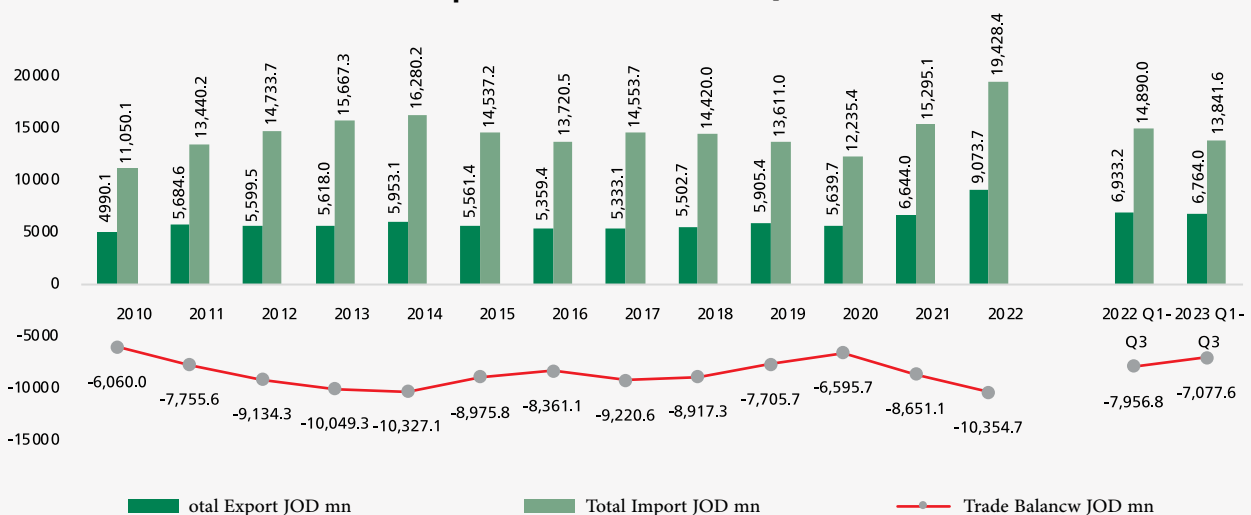
by 11.1% compared to the same period in 2022, reaching 7077.6 million dinars.

**Trade in Services:** The Jordanian economy is characterized as a service-based economy, which necessitates an increased focus on the competitiveness of service sectors at both the domestic and international levels. Alongside the tourism sector, there is a need to further capitalize on other service sectors, such as financial services, telecommunications, and information technology, which keep pace with developments in the digital economy, as well as the transportation sector, which offers immense potential given Jordan's geographic location on trade routes.

The balance of services recorded a surplus during the period (2010-2019), averaging 5.1% annually of the Gross Domestic Product (GDP), compared to a deficit averaging 0.2% during the period (2000-2009). However, in 2020, due to the COVID-19 pandemic, the trade in services balance recorded a deficit of 1.3% of the GDP, marking the first deficit since 2005. It resumed a surplus in 2021, reaching 0.8% of the GDP, approaching levels to reach 4.7% during 2022. During the first three quarters of 2023, it achieved a surplus at a record level of 8.2% of the GDP, attributed to a significant increase in tourism income

## Assumptions Underlying the Macroeconomic Framework (2023-2025)

- Maintaining and expanding levels of domestic and foreign private direct investment.
- Maintaining the current level of capital expenditures over the next three years.
- Maintaining financial and monetary stability and adequate levels of foreign reserves at the Central Bank of Jordan.
- Continuing the implementation of fiscal reforms by reducing the deficit and limiting the growth of public debt and its service burdens.
- Achieving sustainable growth in exports over the next few years.
- Enhancing global economic conditions in terms of supply chains, energy and food prices, and growth rates.
- The continued presence of Syrian refugees as a long-term phenomenon not a temporary one.

## The economic policy and vision for economic modernization (2023-2033)

The government, through its economic policy, aims to accelerate economic growth and improve the citizens' standard of living by granting a larger role to the private sector as a growth engine and unleashing economic potential. This involves diversifying economic activities and focusing on stimulating both local and foreign investments in high-value-added production sectors.

The vision for economic modernization entails creating a comprehensive economic framework and a roadmap for the next ten years. It focuses on economic growth, quality of life, and sustainability, targeting an average annual GDP growth rate of around 5.6%. This is to be achieved by focusing on various economic drivers, including future services, high-value industries, and tourism. Additionally, it aims to attract investments averaging 3.5 billion Jordanian Dinars annually. The results of this growth are expected to be translated into improved living standards by creating one million job opportunities, increasing real income per capita by 3% annually on average, and raising citizens' satisfaction with quality of life to 80% by the end of 2033. Moreover, the aim is to elevate Jordan's ranking in global competitiveness indices to be within the top 30%, while considering environmental sustainability factors.

The economic modernization vision has adopted a gradual path to achieve its targets, aiming for an average growth rate of around 4.3% during the period 2023-2025. Efforts will then be made to stimulate growth rates to approximately 6.5% annually in subsequent years.

As for the current executive program (2023-2025), it comes amidst growing global economic uncertainty and central banks' trend towards continuous interest rate hikes, along with expectations of persistently high oil prices. This has implications for the prices of strategic commodities and shipping, as well as reduced global demand for goods and services, and difficulty accessing financing for developing countries, affecting national exports and foreign direct investment. As a result, the expected economic growth rate is anticipated to average 2.8% annually. In addition to the aforementioned external challenges, the national economy continues to face internal challenges, including structural imbalances in public finance, financial constraints, the burden

of Syrian refugees—especially given the decline in international grants provided to the kingdom to address refugee needs—weak industrial base, heavy reliance on external energy sources, high unemployment rates, and escalating climate change risks amidst increasing scarcity of water resources.

### Financial policy

The government, through effective use of fiscal policy tools, aims to maintain financial stability in the kingdom. This involves achieving secure levels of the general budget deficit and public debt by enhancing tax administration, preventing tax evasion and avoidance, and customs evasion. Additionally, the government seeks to increase the efficiency of government spending and diversify sources of public debt. Through fiscal policy, the government also aims to alleviate financial burdens on citizens, especially tax burdens, and protect the middle class. This is to be achieved by increasing the proportion of direct taxes in total tax revenues, enhancing the social safety net, and avoiding the imposition of new taxes or fees.

### The Monetary Policy

The monetary policy of the Central Bank of Jordan primarily aims, as specified in its law, to maintain monetary and financial stability. Monetary stability in Jordan consists of three elements: firstly, maintaining the exchange rate of the Jordanian Dinar fixed against the US Dollar as a nominal anchor for monetary policy since 1995. Secondly, preserving stable and moderate inflation rates, which reflect the purchasing power of the local currency and help maintain it. Lastly, establishing a moderate structure for interest rates in the long term. This stability, which sits atop the central bank's priority list, is of great significance to the economy as it serves as the cornerstone for overall economic stability. Additionally, the Central Bank of Jordan seeks to achieve other objectives including the implementation of partial and comprehensive prudential regulatory policies that contribute to achieving banking and financial stability in the Kingdom.



## Labor Market

The labor market in the Kingdom faces several structural challenges, with the inability of the national economy to create sufficient job opportunities being at the forefront. This challenge arises from the continuous increase in the number of job seekers, in addition to the competition from both licensed and unlicensed foreign workers for the newly created jobs, and the mismatch between the outputs of the education system and the needs of the labor market. Furthermore, the public sector's capacity to employ has declined due to exceeding its actual needs for employees.

In light of the existing challenges, the government will focus in the coming period on restructuring the labor market. This will involve developing the inspection system, occupational safety and health, automating work-related permits, reducing violations occurring in the work environment (such as child labor), empowering women in the labor market, increasing their economic participation through the application of flexible work arrangements, organizing childcare matters, and other measures that affect citizens' lives and lay the foundation for their future.

On the other hand, the economically active population in the Kingdom was estimated to be only about 32.6% of the working-age population in the third quarter of 2023, while 67.4% were economically inactive. When distributed by gender, it appears that 52.7% of males are economically active compared to only 13.5% of females. The low rates of economic participation represent a missed opportunity for Jordan, as the female labor force participation rate in Jordan is one of the lowest in the world. Moreover, the Global Gender Gap Index reveals that Jordan ranks 126th out of 146 countries in 2023 and is fourth among 13 countries in the Middle East and North Africa region.

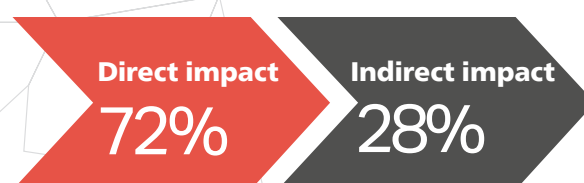

- Alignment with the Economic Reforms Matrix, Sustainable Development Goals, and sectoral strategies and plans.
- Priorities related to women economic empowerment and increasing women economic participation.
- Action plans to improve Jordan's ranking in international indicators and reports
- Setting macroeconomic targets 2023-2025.
- An electronic system to monitor performance and achievement through the Prime Ministry Delivery Unit (PMDU), defining performance and achievement indicators and an (Online Dashboard) that will be accessible by the public.

## Mechanism for Monitoring Progress of the Executive Program

The Prime Ministry Delivery Unit (PMDU) will monitor the progress and delivery of the initiatives and priorities outlined in the Executive Program for the Economic Modernisation Vision. PMDU will provide all forms of technical support to overcome any obstacles that may arise during implementation.

### Monitoring Performance in the Implementation of the Economic Modernisation Vision

The process of monitoring the implementation of the of Economic Modernisation Vision shall be carried out along two parallel tracks to achieve the desired outcomes and goals.

1. Monitoring the delivery of the Vision Executive Program for all initiatives and priorities outlined in the Program via the PMDU follow-up and evaluation team. The progress of the implementation of initiatives and projects will be monitored by liaison officers and delivery units established in the ministries and government institutions for this purpose.
2. Monitoring the implementation of high-priority projects, so that these projects are closely monitored through PMDU team on a daily basis. PMDU will provide all forms of technical support to overcome any obstacles that may arise during implementation.

### Online Government Performance Monitoring System

An online system has been deployed to monitor performance and achievement. All parties involved will utilize the system to provide periodic reports and update data on work progress within the priorities and projects outlined in the Executive Program.
